

## The Women's Economic Council: Portal Naming Giveaway Terms and Conditions

NO PURCHASE IS NECESSARY TO ENTER OR WIN.

1. Eligibility: This Campaign is open only to those who are **16 years or older**, residing in CANADA and are not board members, employees or managers of the Women's Economic Council.

2. Agreement to Rules: By participating, the Participant ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of the Women's Economic Council as final and binding as it relates to the content of this Campaign.

3. Campaign Period: Entries will be accepted online starting January 22<sup>nd</sup>, 2018 on and ending February 16<sup>th</sup>, 2018. All online entries must be received by February 16<sup>th</sup>, 2018 11:59 P.M. EST. The Women's Economic Council holds the right to shorten and lengthen the contest period at any given time.

4. How to Enter: The Campaign must be entered by completing ALL of the following:

- Comment [on the ORIGINAL facebook/, [located on the FACEBOOK account @WomensEconomicCouncil] either a) a pre-given name or b) an original NAME/TITLE for the ONLINE WOMEN'S CENTRE PORTAL THAT the Women's Economic Council is developing.
- Comment a tagline/description for the ONLINE WOMEN'S CENTRE PORTAL
- Liking the Facebook page [FACEBOOK account @WomensEconomicCouncil] for the DURATION of the Giveaway.

**OR:**

- ARE A MEMBER OF THE TESTING PROCESS FOR THE MOCK-UP/TRIAL STAGES OF THE PORTAL AND HAVE LIKED OUR FACEBOOK PAGE. NAMES OF THESE PARTICIPANTS ARE RECORDED BY THE WOMEN'S ECONOMIC COUNCIL.

**OR:**

- ARE A PARTICIPANT OF THE HAIDA GWAII ALL WOMEN'S DIALOGUE SESSIONS, COMPLETE THE "GIVEAWAY SIGN-UP FORM" AND LIKED OUR FACEBOOK PAGE. NAMES OF THESE PARTICIPANTS ARE RECORDED ON THE "GIVEAWAY SIGN-UP FORM" PASSED AROUND BY THE ORGANIZERS OF THE DIALOGUE SESSION HELD ON "January 27<sup>th</sup> and 28<sup>th</sup> 2018.

The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Women's Economic Council. Optional verbiage to include: You may enter only once. You must



provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of [Giveaway Owner].

5. Prizes: The Winner of the Campaign (the “Winner”) will receive a Tablet Value of approx [\$160]. Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by the Women’s Economic Council. No cash or other prize substitution shall be permitted except at the Women’s Economic Council’s discretion. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, provincial, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for the Women’s Economic Council to use Winner’s name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

6. Odds: The odds of winning depend on the number of eligible entries received.

7. Winner Selection and Notification: Winner will be selected by a panel of judges chosen by the Women’s Economic Council. Winner will be notified by Facebook private message by August 2018 following selection of Winner. The Women’s Economic Council shall have no liability for Winner’s failure to receive notices due to spam, junk e-mail or other security settings or for Winner’s provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 30 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this Campaign is conditioned upon compliance with any and all federal, state, and local laws and regulations. **ANY VIOLATION OF THESE OFFICIAL RULES BY WINNER (at the Women’s Economic Council’s sole discretion) WILL RESULT IN WINNER’S DISQUALIFICATION AS WINNER OF THE CAMPAIGN, AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.**

Rights Granted by You: By entering this content (e.g., photo, video, text, etc.), You understand and agree that the Women’s Economic Council, anyone acting on behalf of the Women’s Economic Council, and the Women’s Economic Council licensees, successors, and assigns, shall have the right, where permitted by law, to print, publish, broadcast, distribute, and use in any media now known or hereafter developed, in perpetuity and throughout the World, without limitation, your entry, name, portrait, picture, voice, likeness, image, statements about the Campaign, and biographical information for news, publicity, information, trade, advertising, public relations, and promotional purposes. without any further compensation, notice, review, or consent. Optional verbiage for Giveaway: By entering this content, You represent and warrant that your entry is an original work of authorship, and does not



violate any third party's proprietary or intellectual property rights. If your entry infringes upon the intellectual property right of another, You will be disqualified at the sole discretion of the Women's Economic Council. If the content of your entry is claimed to constitute infringement of any proprietary or intellectual proprietary rights of any third party, You shall, at your sole expense, defend or settle against such claims. You shall indemnify, defend, and hold harmless the Women's Economic Council from and against any suit, proceeding, claims, liability, loss, damage, costs or expense, which the Women's Council may incur, suffer, or be required to pay arising out of such infringement or suspected infringement of any third party's right.

9. Terms & Conditions: the Women's Economic Council reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Campaign should virus, bug, non-authorized human intervention, fraud, or other cause beyond the Women's Economic Council control corrupt or affect the administration, security, fairness, or proper conduct of the Campaign. In such case, the Women's Economic Council may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by the Women's Economic Council. The Women's Economic Council reserves the right, in consultation with our stakeholders, not to choose any name submitted in the giveaway. The Women's Economic Council reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions. The Women's Economic Council has the right, in its sole discretion, to maintain the integrity of the Campaign, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots, macros, scripts, or other technical means for entering. Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the Campaign may be a violation of criminal and civil laws.
